## **“LEGISLATIVE REPORT”**

REGINALD BUTT CHAIRMAN

1. It time to call your Congressmen and woman and New York Senators. The Flag Amendment bills are back on the table. Senate Joint Resolution 19 and the House Joint Resolution 13 propose a constitutional amendment to protect the American Flag from physical desecration. The text states simply “The Congress shall have power to prohibit the physical desecration of the flag of the United States”. When you call the Congressman and woman and the Senators ask them to co-sponsor these resolutions. If they state they have “THANK THEM”. I called Congresswoman McCarthy and was told she would co-sponsor but call again.

2. The American Legion has reacted strongly in support of legal action that alleges unlawful religious discrimination against America’s veterans on part of the Houston National Cemetery. It is claimed that on at least 4 separate occasions, government officials told Legion and VFW burial teams in Houston that prayer and religious speech could no longer be included in burial rituals unless the family of the deceased submits a specific prayer or message in writing to the Director Ocasio for her approval. They were also told that the use of the word “GOD” is forbidden in unapproved ceremonies. A court case is pending.

3. The American Legion has told the White House to appeal Court’s ruling on “Don’t Ask Don’t Tell”. This ruling has been issued by the Ninth Circuit Court of Appeals. This ruling reinstated an earlier injunction by a lower court which was later reversed. The legion states “This lack of consistency and expertise by the courts makes it very difficult to operate a first-rate military, much less fight two wars.

#### **American Legion Action Alert:**

Don’t Let Them Set the Agent Orange Clock Back.

On July 19th Senator Tom Coburn (OK) introduced a Senate Amendment to HR 2055, the 2012 appropriations bill for funding military construction and the Department of Veterans Affairs. The bill, commonly called the Milcon/VA bill, would be amended by Senator Coburn’s propoal to change the medical standards used to determine presumptive conditions associated with Agent Orange.

**“Do not let this amendment pass!”**

This amendment would change the standard of medical evidence in studies from “positive association” to “casual relationship” The positive association standard was established in 1991 and has been in use for the past two decades. Causal relationship is a far more stringent and onerous standard. Furthermore it throws out years of precedent in VA claims Systems for the phantom promise of fiscal savings. The current system of careful scientific review of medical studies and research by the Institute of Medicine is a cautious system that nonetheless has provided exhaustive research reviewed every two years by the VA.

**Do not** stand for Congressional attempts to rewrite the system to make the fight harder for future generation of veterans. The Vietnam veterans and their successors have fought too hard to lose ground on this crucial issue.

The American Legion is calling on it membership to immediately contact their senators and to contact Senator Coburn’s office and tell them they will not stand for this attack on the veterans of Vietnam and other eras.

Tell them **NO** to Senator Coburn’s Senate Amendment #564 to HR 2055.

5. NYS Governor Andrew Cuomo to day signed a law that enhances the job security for public employees Serving in the Military.

Assemblyman Robert J. Castelli, author of the measure and Ranking Member of the Assembly Veterans Affairs Committee, bill amends the Civil Service Law and the Military Law to Prohibit public employers from abolishing positions based on a person’s military status. Under the measure, public employers are mandated to comply with the Federal Uniformed Services Employment and reemployment Act (USERRA) of 1994, and public employers are expressly prohibited from denying employment, employment benefits, or re-employment rights to any person or prospective employee based on past or current military service.

Veterans Affairs Voluntary Service (VAVS)

I am writing this message in order to drum up support for the Department of Veterans Affairs Voluntary Service (VAVS) program for the American Legion. As you all are aware, the American Legion is pushing to do ONE MILLION hours of service for VAVS. We are currently at 943,829 hours. This is just under 57,000 hours left to complete by October. Please try to push your Departments to help the American Legion achieve its goal. If you would like to commit to a certain portion of this as a Department goal, please let me know. I commend all of you and your contributions thus far and just ask for a little more assistance to make it happen.
